My teaching responsibilities at UCL included organizing the Child and Systemic teaching modules as well as providing scientist-practitioner oriented teaching in areas such as Attention Deficit Hyperactivity Disorder (ADHD), Conduct Disorder (CD), combining developmental psychopathology and affiliated systemic conceptual models in child practice (e.g, Bronfenbrenner), Child Anxiety Disorder, Depression and the Family, Parenting and Divorce, Introduction to Clinical Practice with Children, Adolescents, and Families, as well as sessions on Multi-systemic therapy (MST) and leading clinical seminars on working with children where students brought clinical material and questions. For our initial broad themes unit I taught developmental psychopathology, and integrate into my teaching on all of the above topics. Additionally, I have taught undergraduate teaching at both UCL and UPEI, and as a graduate student at University of Ottawa, in areas such as introduction to psychology, developmental psychology and contributed to undergraduate teaching

designed to introduce students to the range of major mental health conditions across the lifespan as well as the core conceptualization and evidence-base related to them.

1. Involvement in the Mentalization for Offending Adult Males (MOAM): I continue my involvement in this project through contributions to papers that continue to emerge from trial data and that are included in the section of publications.

- 2. Young people social media use: I continue to be involved in research in this area with my collaborator from UCL, Marc Tibber, as well as graduate and honours students from UPEI. Marc and I are currently drafting a paper detailing a social media intervention for adolescents and young adults.
- 3. Modern Market Cultures and Young People's Mental Health and Well-Being: This is an ongoing project where I have developed evidenced-informed theoretical frameworks evidenced by my publications in 2019, 2021, and 2024(2), and conference presentations in Canada and Denmark in 2019 and 2020, and Oslo in 2025.
- 4. My current doctoral student supervision spans my role as the key child mental health academic in the department and involves a quantitative study of young people's self-commodification on social media, qualitative studies of parental expereinces where their child has been diagnosed with autism, and where they are caring for child with life-limiting conditions, and critical theory or conceptually-based theses that are looking at sexual diversity in light of psycholanalysts Jacques Lacan's writings, and expanding a culturally-informed model of eating disorders to include object-relations and feminist perspectives.
